



## CALL FOR PROPOSALS

### Assessing featured OGP commitments

The Open Government Partnership (OGP) is inviting proposals to assess if and how OGP reforms have changed government policy, practice and services and made a tangible difference in peoples' lives. A total of 5-7 grants of USD 5,000 each will be awarded competitively to journalists, researchers or organizations that meet the criteria for proposals.

#### Background

Since OGP was launched in 2011 nearly 75 national and 15 subnational governments have made over 2500 individual open government reform commitments. As part of the OGP's knowledge and research agenda, we continue to capture stories of how OGP reforms change government policy, practice and services and impact peoples' lives. In 2016, OGP published '[Early results from OGP initiatives](#)' which assessed the short to medium term outcomes of reforms from 2011-12 National Action Plans in seven countries. They cover transparency, accountability and public participation reforms related to a wide range of public policy issues. Through this call for proposals OGP is now requesting submissions for the **second edition** of this publication.

#### Main objectives

The project has the following objectives:

- Capture and assess the short and medium term outcomes of OGP reforms, telling a story of whether and how OGP commitments have resulted in positive changes in policy, practice or services for citizens
- Showcase OGP's contributions at a global stage; documenting the role of OGP in catalyzing the reforms, and developing a strong value proposition for the open government movement

#### Grant details

- A grant of USD 5,000 will be made for each case study.
- Depending on the nature and scope of the case study and the anticipated fieldwork required, small extensions may be considered after the initial selection of the proposals.

#### Research description

##### **Central research question**

*What are the changes in policy, practice and services that have come about as a result of the implementation of the OGP commitment and how have these changes benefited citizens?*

##### **Scope**

The proposed research should assess commitments from a suggested list of 140 commitments from the 2013-2014 OGP National Action Plans (see Annex). The [Independent Reporting Mechanism \(IRM\)](#) has produced reports analyzing the progress of these 140 OGP commitments. The reports assess whether the commitments made were

relevant to open government principles, ambitious in their potential impact, the degree to which they were implemented and their effect in opening government in the short term. **Through this research, applicants must add value to the IRM assessment of the commitment, by investigating the role of OGP in the success of the reform, and crucially, highlighting the human stories behind the reform in a compelling manner.** Researchers are also welcome to propose OGP commitments not on this list that have made sufficient progress in implementation to allow for an assessment of outcomes.

## Deliverables

- The final deliverables will include: written case studies (5 pages maximum per commitment), documented interviews with key stakeholders, and a ‘portrait study’ of an individual who has benefited from the reform.
- The contracts may be extended after the submission of the first draft for additional derivative outputs, including working with a video production team for capturing the case studies in video format.

## Process for submission of applications

Proposal submissions should be **no more than 3 pages**, and include a rough budget and a full set of CVs (limit of 2 pages each). Submissions must be in English. The proposal should include:

- **Justification:** Include the specific commitment(s) for your research and explain your selection
- **Methodology:** research methodology, and anticipated data sources.
- **Project plan:** including milestones, consistent with the overall timeline provided above.
- **Research team profile:** Profile of the researcher or research team including qualifications, previous work samples and organizational capacities.
- **Total grant amount requested:** based on number and nature of commitments, researcher time, and costs for any in-country travel.

Researchers are encouraged to read the first edition of the [‘Early Results of OGP initiatives’](#) before submitting a proposal. Please note that in making the final selection on the grants to be awarded, the assessment committee will take into account the diversity of open government topics, countries and regions represented. Multi-country studies on a single open government topic are out of the scope of this call.

### Who should apply?

Researchers/research teams or journalists with:

- At least 3 years of expertise and experience in the government transparency and accountability field
- Strong track record of publications in academic forums, peer reviewed journals or leading newspapers and new media channels
- Experience in interacting with a wide variety of actors. e.g. policymakers, government officials and civil society actors.
- Capacity to undertake the research (e.g. knowledge networks, country or regional expertise etc.)  
Researchers/journalists based in or with local presence in the country of the proposed commitments under study are encouraged to apply.
