Proposed changing the project participation rules

The proposed 1+1 project participation rules for EUREKA Individual projects and EUREKA (sub)Cluster projects with participation of EUREKA NIP (and Associated countries) can be applied under the following criteria:

- Project consortium must be composed at least by one EUREKA member country and one NIP(and/or Associated country);
- NIP (and/or Associated country could be main partner in a project);
- A balanced project partnership is necessary.

The final approval of proposed changing project participation rules is under consideration of EUREKA MC in June 2012 in Budapest.
