We are project managers, facilitators of knowledge exchange, and supporters of European projects that connect people and cultures. In short, we are EACEA.

Erasmus+ is the EU's programme for supporting education, training, youth and sport in Europe. Over the last 35 years it has offered life-changing experiences to more than 13 million participants.

Through Erasmus+, we support projects that give individuals the chance to study, train, gain work experience and volunteer abroad, and which help organisations to take part in transnational partnerships.

At EACEA we also manage the **Erasmus+** programme's **Eurydice** network, which provides reliable and comparable information on European education systems and policies, as well as the **Youth Wiki** platform, which serves as Europe's online encyclopaedia of national youth policies. We also publish numerous studies and analysis of education systems and youth policies each year.

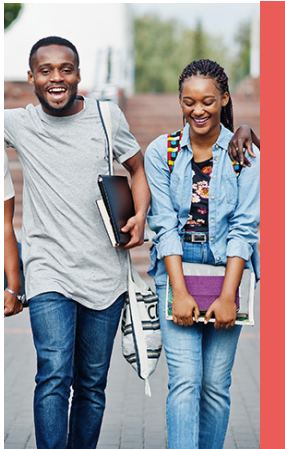


Applying for EU funding

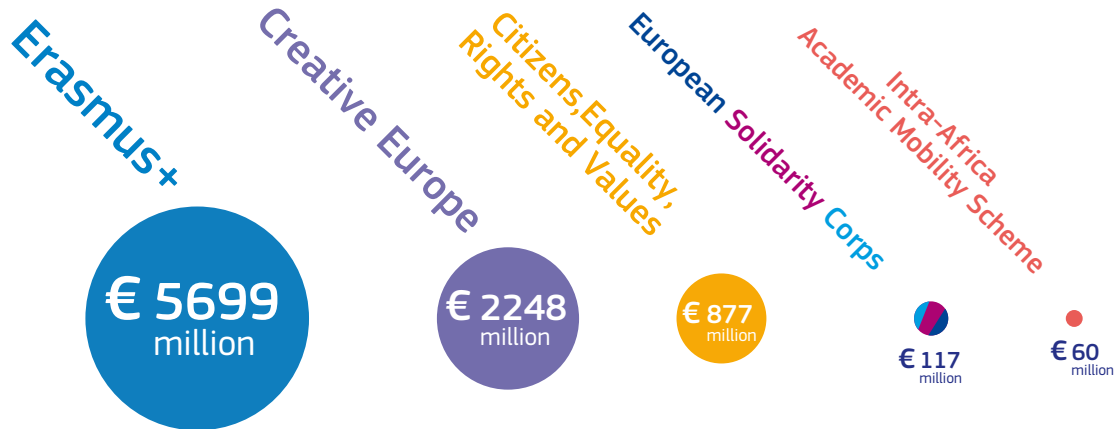
