Executive Summary

Two CSAs (Coordination and Support Actions), SCORE and BAFN (identified under T1.4 in Work Package 1) which already perform S&T priority setting exercises have been screened. Their methodologies for priority setting have been recorded and assessed.

Secondly, S&T priority setting exercises in the Western Balkan countries (WBC) at national level have been surveyed as regards their input in the WBC-INCO.NET priority setting process.

In Annex 3, the WBC perspective on national priority setting processes for 2009 is presented based on the regional research priorities identified under T2.4.

In Annex 4, an update for the WBC national priority setting processes for 2013 is presented for two countries.

2. Preliminary results of the screening and monitoring of CSA's, a comparison study

This chapter includes the preliminary results of the screening and monitoring of selected CSAs which already perform S&T priority setting exercises.

1.1. Methodology

GSRT had sent an official letter to the coordinators of the identified CSAs, informing them about the purposes and the aim of this screening exercise asking for their contribution. A relevant questionnaire had been sent together with the letter trying to formulate the methodology that was followed in each case concerning the priority setting. Extensive interviews had been implemented with the key persons involved in the S&T priority setting processes. After the recording process a comparison exercise of the different methodologies had been followed and finally an assessment.

1.2. Introduction

Two thematic projects targeted to the better integration of the WBC into the European Research Area had been identified:

SCORE- Strengthening the strategic cooperation between the EU and West Balkan Region in the field of **ICT research** (http://www.score-project.eu)

Balkan Agro Food Network- Support the opening of the European Research Area by developing a sustainable network in **agricultural and food sector** in the Western Balkan (http://www.europartnersearch.net/bafn)

Both projects performed S&T priority setting exercises. In both projects' surveys were not included Croatia and Montenegro

1.3. Common Approach

The 2 projects have a common approach. More specifically, they

- are financially supported by the European Union under the FP6
- include partners from the WBC and the EU countries
- aim at defining future research priorities that will enhance RTD co-operation in the area of Information & Communication Technologies (ICT) or the area of agri-food sector between the Western Balkan Region and the EU
- develop a Policy Paper or a Position Paper with "Recommendations" for shaping EU scientific co-operation with the Western Balkan Region.

1.4. Common Methodology

The 2 projects have a common methodology. More specifically, they determined research priorities from a national perspective in each WBC. The consultation process was not prolonged to the definition of joint priorities across national borders in the WBC region. Moreover in both projects a combination of "expert consultation" and "open consultation" was used.

1.5. The research priority setting step by step

1.7. Deliverables

For the SCORE project the results are the "Commonly accepted research priorities and objectives that reflect the actual socio-economic needs and research capabilities of the Western Balkan countries and correlates them with the ICT Challenges of FP7."

In total, 13 ICT priorities were defined and divided into 2 groups:

- a) Feasibility/ readiness including: Social Importance, Economic Importance, Strategic Importance & Research and Technological Opportunities
- b) Attractiveness/ potential including: Application Capacity (absorption potential of application sectors) and Research & Technology Capacity (production potential of R&D)

In the table that follows are presented these ICT research priorities

For the BAFN project the results are:

12 priorities recommended by WBC researchers in two groups:

6 areas for which cooperation would help to develop existing research capacity:

Food technology

Plant science

Animal science (animal breeding, animal husbandry and animal nutrition)

Food safety

Fishery and to medicinal plants

Biodiversity with the preservation of indigenous species and traditional food products.

6 areas for which cooperation would help to answer future needs:

- Research in typical national food products, biodiversity conservation
- Research on zoo noses which have influence in human health and in animal production
- Quality systems on food technology
- Sources of food allergens
- Food safety: chemical contaminants in food, food allergens and toxins in food
- Dietary supplements

Additionally 6 priorities were recommended by EU representatives..

Finally in summary 4 scientific areas were recommended suitable for the cooperation between the European Union (EU) Member States and the Western Balkan Countries (WBC):

- 1) Biodiversity: conservation of genetic resources & indigenous species
- 2) Food safety: chemical contaminants in food, food allergens and toxins in food
- 3) Animal science: animal husbandry and zoonose
- 4) Food biotechnology: nutrition and dietetics

1.8. Risks analysis

The risk analysis of the two screened methodologies had identified the following points:

• The content of the consultation document and the questionnaire that is distributed to the panel experts for their contributions.

The consultation document provides an overview of the thematic research environment in each country, the European research collaboration dimension, taxonomy and a set of questions for consultation. The abovementioned document and questionnaire could guide or influence the experts.

Moreover, there is limited information available and low quality of information in some fields.

• The identification and selection of the panel experts for the targeted consultation (representing research, industry and policy-makers).

There is a lack of expertise/know-how in some fields. The experts should specify to what extent they are able to rate different research topics based on their expertise. Scores with a high degree of expertise should be counted more in the aggregate scores.

Experts used to have specific interests and own priorities in their mind. Many times there is a conflict of interests between experts.

• The open consultation process (based on prepared databases – direct and indirect stakeholders).

The stakeholders usually support their own interests.

 The joint research priorities in the WBC region are a synthesis of individual procedures (expert panels, open consultation) in each WBC.

Joint multilateral workshops with stakeholders from the WBC are needed.

Work Package Title

3. The WBC perspective on priority setting, existing approaches. An on-going survey

This chapter includes the WBC perspective on national priority setting processes.

2.1 Introduction

In order to identify the S&T priority setting processes at national level in the WBC, GSRT circulated a questionnaire. It included 11 questions and it had been addressed to the policy makers in the relevant Ministries in the WBC. Feedback was provided by Croatia, Montenegro, Former Yugoslav Republic of Macedonia, Serbia, Bosnia-Herzegovina and Albania.

2.2. Questionnaire

The questionnaire included the following questions:

- D Q0. Do you have national S&T priorities?
- D Q1. If YES in which depth your national priorities have been defined (i.e. Information Communication Technologies (ICT) – ICT solutions – e-business?)
- D Q2. Is the definition of your national S&T priorities the outcome of a national initiative? If NOT under whose supervision and support was it implemented?
- D Q3. Could you describe the methodology that your national S&T priorities came up? (i.e. Policy makers' decision, National foresight exercise, national surveys and studies, SWOT analysis, national panel of experts, international panel of experts, thematic conferences or workshops, open consultation etc)
- D Q4. Could you identify which were the key issues that influenced your national S&T priorities setting? (i.e. Economic Importance, Strategic Importance, Research & Technological Opportunities, Application Capacity (absorption potential of application sectors, Research & Technology Capacity (production potential of R&D)
- D Q5. Could you describe some lessons learnt from your national S&T priorities setting (i.e. lack of expertise/know-how in some fields by experts, potential conflicts of interest between experts etc)
- D Q6. Are your national priorities described in an official document? (i.e. legal document, action plan, operational programme etc)
- D Q7. Are your national priorities influenced by the priorities of FP6 & FP7?
- D Q8. Are your national priorities influenced by your bilateral co operation with other countries and the "demands" of the counterparts?
- D Q9. How often do you update your national priorities?
- D Q10. Do you apply your national priorities (as your national research strategy) in all your national programmes and calls? Are there any deviations?
- D Q11. Do your national priorities influence your educational system? (i.e. support of labs or PhDs that are in line with these priorities).

In Annex 1 are presented the completed questionnaires.

2.3 Identified national S&T priorities

Croatia, Montenegro, Former Yugoslav Republic of Macedonia, Serbia and Albania have already defined their S&T priorities.

In Bosnia & Herzegovina, during this year, the Ministry of Civil Affairs is planning to work on a Strategy for development of science in the country including the S&T priorities. This process has to involve somehow the two entities and ten cantons of the country, each one of which has competencies in relation to science.

The situation of conflict of interests between the experts and policy makers was very evident because of the fact that we suffer of some overloaded scientific fields (in terms of human capacities) which are not among the priorities. There are a lot of experienced and high qualified researchers in sectors which are not amongst their national priorities. These are usually some technical fields with very restricted list of scientists with certain demands toward the research community, especially in the way of setting priorities and the future funding system.

Results on national S&T priority setting in the WBC for 2009

In 2009 all WBCs have identified their national S&T priorities, except from Kosovo (under UNSCR1244), where the identifying process is still ongoing under the umbrella of the National Research Council.

The national S&T priorities are quite similar in the region, with ICT, Health, Environment, Agriculture and Food, Energy, Materials, Social Sciences and Humanities (SSH) coming first on the list, coinciding mostly with the results of the consultation sessions held under T2.4.

Envisaged to be integrated in all national programmes and calls, they influence both the educational and the research system, whereas they are being updated every 3-5 years, with the exception of Montenegro that sets priorities for the first time covering a period of 8 years (2008-2016).

The definition of national priorities, as described in state official documents, is still the outcome of a national initiative, mainly based on consultation between policy makers and national experts, with surveys and studies serving as background documents. This is also highlighted by the fact that the national priorities are only partly influenced by the FPs and the cooperation with other countries.

When defining national S&T priorities, the WBCs are driven by common issues, mainly the economic impact and the application capacity. On the other hand, important restraining factors concerning the S&T priority setting, such as the conflict of interest between researchers and policy makers or insufficient infrastructure in key domains, still exist.

Regarding the consultation sessions under T2.4, most of the identified regional priorities coincide with the national ones. In some WBCs¹ the consultation process in the project has been used as a valuable source of information when building national

-

strategies and priorities. On the contrary, in Albania, Former Yugoslav Republic of Macedonia and Montenegro the regional priorities were not taken into consideration when defining their national ones, since this process as well as their strategy building had already been completed at the national level at that time. In these countries the consultation session results will be taken into consideration in the next period of priority setting/strategy building. Instead, Kosovo (under UNSCR1244) stands as an exception, because the consultation session results of T2.4 have been used both for national priority setting and strategy building.

All in all the key development compared to 2008 is that in 2009 six out of seven WBCs have finished to set their national S&T priorities (Kosovo under UNSCR1244 is at the moment under the process of definition), which mostly coincide with the regional research priorities identified under T2.4. Furthermore, all WBC have used or are willing to use more or less the results of the T2.4 consultation sessions when building up their national strategies and priorities. Apart from these findings, not much has changed since 2008 as most WB countries have defined their national priorities recently (see also Preliminary Conclusions in 2.15, p. 22).

Results of the survey on priority setting in the WBC for 2009

As only one year has passed since the first circulation of the questionnaire in the region, the WBCs have been asked to answer the questions 12 and 13 referring to the priorities identified under T2.4, and in addition to give answers to the rest of the questions only if changes have occurred within 2009.

A 15-member NRC appointed a 35-member Working Group of Experts (WG) which also involves NRC members. Two workshops were organized to facilitate discussion within WG. In certain fields we had background studies including those developed within WBC-INCO.NET, whereas in some other fields we had to have a more indepth discussion among experts to get a sound understanding of the situation.

Q4. Could you identify which were the key issues that influenced your national S&T priorities setting? (i.e. Economic Importance, Strategic Importance, Research & Technological Opportunities, Application Capacity (absorption potential of application sectors, Research & Technology Capacity (production potential of R&D)

The first step was to define criteria based on which we judged the priority fields. Six criteria were agreed in the WG:

- Relevance to economic and social development of the country
- Sufficient and quality cadre for this field within the country and Diaspora
- Condition of research infrastructure in terms of its base for research activities
- Contribution to preservation and promotion of national identity of Kosovo²
- Potential to achieve research results and apply them in the country and abroad
- Existing international cooperation which helps research in this field

Q5. Could you describe some lessons learnt from your national S&T priorities setting? (i.e. lack of expertise/know-how in some fields by experts, potential conflicts of interest between experts etc)

Although there is still an ongoing public discussion, we observed biases and conflicts of interest. It was very difficult to convince people that non-priority fields will not be neglected, but they cannot be based on additional support from the Government.

Q6. Are your national priorities described in an official document? (i.e. legal document, action plan, operational programme etc.)

They will be described in the National Research Program (NRP) 2010-2015 which is the main policy document for research in Kosovo and needs to be approved by the Parliament.

Q7. Are your national priorities influenced by the priorities of FP6 & FP7? Not directly, although they match.

Q8. Are your national priorities influenced by your bilateral cooperation with other countries and the "demands" of the counterparts?

To a certain extent, in terms of criteria listed under Q4.

Q9. How often do you update your national priorities?

This is the first time they are explicitly defined. By Law, NRP's duration is four years.

Q10. Do you apply your national priorities (as your national research strategy) in all your national programmes and calls? Are there any deviations?

No experience with calls yet. First calls will be launched in 2010.

- It is anticipated in the NRP 2010-2015. We believe that education of young researchers should be one of the pillars of the NRP and ways for implementation of research priorities.

They have been used in discussions, but they were not necessarily included in the NRP.

No, because there have been no processes of building up the national strategies and priorities in the meantime. They will be taken into consideration in the next priority exercises.

A: Yes, S&T priorities are defined under the National Research Program 2010-2015 which was developed by the National Research Council and approved by the Kosovo Parliament.

Q: Could you describe the methodology that your national S&T priorities came up? (i.e. Policy makers' decision, National foresight exercise, national surveys and studies, SWOT analysis, national panel of experts, international panel of experts, thematic conferences or workshops, open consultation etc)

A: In order to ensure a participative approach, two dedicated two-days working meetings with a high number of representatives from the research sector were organized. The first one was held in Mavrovo in September 2009 and the second was held in Thessaloniki in November 2009. In between and afterwards several smaller consultation workshops were organized. The list of contributors to the document preparation process is provided in the Annex 1. Draft of the National Research Programme was approved by the NRC on 11 February 2010 and was authorised for public discussion. On 3 March 2010 a National Conference was organised in Prishtina with the aim to discuss the draft Programme, with participation of over 100 researchers from Kosovo. Suggestions from public discussion had a significant impact in shaping the final version of the Programme

Q: Could you identify which were the key issues that influenced your national S&T priorities setting? (i.e. Economic Importance, Strategic Importance, Research & Technological Opportunities, Application Capacity (absorption potential of application sectors, Research & Technology Capacity (production potential of R&D)

A: The following six criteria for priority setting were used:

- Relevance to economic and social development of the country,
- Number and quality of human resources for within the country and Diaspora,

- Condition of research infrastructure.
- Contribution to preservation and promotion of national identity of Kosovo,
- Potential to achieve research results and apply them within the country and abroad,
- Existing international cooperation in a field.

Q: Could you describe some lessons learnt from your national S&T priorities setting (i.e. lack of expertise/know-how in some fields by experts, potential conflicts of interest between experts etc)

A: Given a long period of isolation, there was a strong tendency to include all possible disciplines in the priority list. Initially, a list of 26 priorities was compiled. This is where the conflict of interest was present. On the other hand, lack of experience in planning was anotherlimiting factor. In this case, expertise available through an Austrian project was very valuable.

Q: Are your national priorities described in an official document? (i.e. legal document, action plan, operational programme etc)

A: Yes, the National Research Program 2010-2015 is a public document approved by the Kosovo Parliament

Q: Are your national priorities influenced by the priorities of FP6 & FP7? A: Only to a limited extend

Q: Are your national priorities influenced by your bilateral co operation with other countries and the "demands" of the counterparts?

A: No

.

Q: How often do you update your national priorities?

A: This was the first time that Kosovo set its national priorities, so no update has been made to date

Q: Do you apply your national priorities (as your national research strategy) in all your national programmes and calls? Are there any deviations?

A: Yes, to a large extend. There are not many calls, and no major deviations from agreed priorities were observed. However, one should recognize that the priorities are rather broad.

Q: Do your national priorities influence your educational system? (i.e. support of labs or PhDs that are in line with these priorities).

A: Yes, as explained in previous question

Q: Have you used the priorities defined in the T2.4 consultation process in the national background reports for building up your national strategies and priorities?

A: Yes, the reports proved to be very useful for setting national priorities, particularly in the field of Health, Agriculture, Environment and ICT, since those reports were available when the National Research Program was developed. However, this does not apply to background reports on Transport which was not considered to be a national research priority, neither to those on SSH and Energy which were developed later.

Q: Do the regional research priorities defined under Task T2.4 and commonly agreed upon by all WBC coincide with your national priorities or have they been used for strategy building? A: They do, particularly in those four fields that were discussed on regional level before the development of the National Research Program was completed (see previous question).
