VI Council

After successful organisation of previous **five Councils** with **more than 500 participants** and **almost 200 published papers**, bearing in mind that Laws on energy efficiency in FBiH and RS were adopted, more than ever, there is a need to exchange expert opinions in the field of energy efficiency (EE) and renewable energy sources (RES). In the atmosphere of positive changes in BiH in the field of sustainable development, we are honoured and pleased to announce the **VI Council in the period 28-29 of September 2017 in Neum**.

CETEOR has always tried to involve key institutions in this field while organising of Councils such as **Environmental Fund of FBiH, Ministry of Energy, Mining and Industry of FBiH** and many local and international organizations. In this way, the synergy between the needs of the market and the support of these organizations has been achieved, providing multiple benefits for participants.

The entire region of the Western Balkans, and therefore Bosnia and Herzegovina, is at a crossroads when it comes to **energy planning**. Energy plants that were built during the time of the former Yugoslavia are still in operation, but in the forthcoming period, they will need to invest in their revitalization for their further work. Another possibility is to invest in innovative techniques and technologies in order to meet energy needs, primarily energy efficiency and renewable energy sources. In whatever direction the **energy development** goes, the price of this development will fall at the expense of the end customers, which are mostly citizens. Therefore, the key issue of this year's Council, is the **energy turn path (Energiewende)** from fossil fuels to energy efficiency and renewable energy sources, through **demonstration of practical experiences**.

Expected participants of the Council are:

- representatives of **ministries / institutions** responsible for energy supply, energy efficiency and renewable energy sources and environmental protection, equipment and building materials manufacturers in the field of EE and technology for the use of RES;
- representatives of **international and local organizations** which implement projects in the field of EE and RES;
- **experts and managers** from energy organizations, industry, buildings and transport, scientific and financial institutions;
- representatives of **local communities**;
- **Investors** in EE and RES and **NGOs**.

Having in mind the current level and tendencies of the energy sector development, this year's Council consists of three segments with several topics which will be addressed, giving special focus on **energy efficiency and renewable energy sources in practice.**
