Introduction

Dear all,

The Economic Conference Montenegro 2022, after a two-year break, is being organized again in a traditional way, gathered at hotel Splendid from October 26 to 28.

Complex health situation and other challenges that the world has been facing made us change our habits, and business models, thus deeply affected the economic and social circumstances. Therefore, we decided to dedicate this year's Conference to Conversations about Future. Exactly this is the topic of this year's event and in the course of the three-day work, we will tend to open full discussion with selected speakers aimed at obtaining answers of importance for the business community of the region and beyond, but also for the society as a whole.

Given that 2022 has been declared the European Year of Youth, which is also the generation to which the Chamber of Economy, as the institution that contemplates responsibly about future, dedicates special attention, we are starting the Conference with the edition for young people. Their representatives, with the business experience, will deliver their recommendations to the decision makers aimed at improving the position of young people in the Western Balkans and increasing their employability in order to reduce migration and emigration from the region.

The success stories that will be shared during the Panel, which testify to the fact that the Diaspora is a great potential, will certainly make us pay greater attention to this fact and to its multiplying effect.

The EU initiatives and synergies for the smart and green future are an indispensable topic of all events focused on the sustainable growth and the future. Consequently, and as a result of the series of initiatives it has taken in the previous years, the Chamber, supported by the project financed through the Horizon Europe program, is contributing to the consideration of these issues.

Harmonization of the education system and the labour market is a topic that has been high on the priority list of the Western Balkan countries for years. It could be said that none of the countries in the region has established a balance there, which is why national economies suffer significantly. There are also numerous projects that the EU has launched in order to encourage us to achieve better results. I expect that the special panel will be dedicated to giving the guidelines that will lead us to the desired results.

There is a number of factors that have moved us from the real world to the online world, and the COVID-19 pandemic has additionally contributed to this. What is the level of our digital literacy awareness and transformation, above all as a business community, is the question to which we must give a realistic answer, especially since we want to reach the accelerated pace at which the world is heading in this area? It is precisely with this intention that we open this topic in the framework of our Conversations about Future.

The unpredictability of the global market, low competitiveness compared to the industrially advanced and developed countries, high-priced access to finance are the obstacles that our companies are facing every day. Despite all that, it turned out that the region has numerous

success stories and businessmen who know how to survive even in the time of crises. They have something to say, and good examples should always be listened to and followed.

Briefly, that's what the Chamber has prepared for this year's Conference, while being convinced that we will reach the desired answers and having hope that the European Union's refocusing on the Western Balkans through the Berlin process will bring us new chances.

As in the previous years, B2B meetings will be held within the Conference, as an added value of this event. May our gathering here be a place for new agreements and business arrangements this time as well.

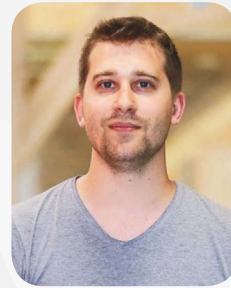

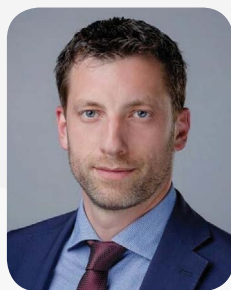
