- 3. Facilitation of regional donor coordination;
- 4. Methodologies, Guidelines, Visibility and awareness raising on REA.

- 'Economy fiches'- state of play and recommendations compiled;
- SEE 2020 Programing Document 2018-2020, reflecting REA needs;
- RCC AWP 2018, great emphasis on MAP REA implementation.
- Regional Donor Coordination meeting, reflecting REA focus;

## **R&D related actions in MAP**



#### In a nutshell the actions outlined in the MAP address the following :

(1) mobility and cooperation between researchers in the WB and between the WB and the EU; (2) the importance of research infrastructure and the investment into infrastructure; (3) digital innovation; (4) smart specialisation; technology transfer; (5) commercialisation of public research and the innovation potential of small and medium size enterprise.

#### Multi-annual regional projects:

# **Mobility - Deliverables**

EU and donors-led deliverables:

- WB Platform on Education and Training (DG EAC and NEAR) close cooperation on actions on mobility of students and academics;
- WB Platform on Research and Innovation (DG R&I) close cooperation on R&D related actions;
- EU4Tech project coordinated by DG NEAR and DG JRC on supporting technology transfer in the region;
- EDIF through the TA instrument conducting a mapping of potential Centres of Excellence in WB6 with an aim of identifying those with greatest potential for funding (these to be presented at EDIF PAG in June);



### Next steps - Mobility deliverables by Sofia summit Regional deliverables

- Identified national and institutional obstacles and recommendations to support incoming and outgoing mobility of researchers;
- Agreed concept of a scheme to support regional mobility of researchers (this will be discussed and agreed at the next WG meeting of Mobility of Researchers end of April (date tbc);

#### Economy specific deliverables

To Albania, Kosovo\* and BiH:

 Appoint responsible Ministry for coordinating the smart specialization strategy development and set up an inter-governmental working group on smart specialization strategy (MAP II.1.6; Deliverable: All economies ready to start developing smart specialization strategies)

(Joint workshop on governance of S3 and training on EDP 11-12 April Ljubljana, RCC & DG JRC)
