





CEI RESEARCH FELLOWSHIP PROGRAMME CERES

I. SUMMARY

The **CEI Research Fellowship Programme - CERES**, co-funded by the FP7/People - Marie Curie Actions, is meant to promote transnational mobility (incoming) of scientists from the 18 CEI Member States¹.

CERES envisages 30 post doctoral fellowships to be distributed over a period of 44 months (2009 – 2012).

II. DESTINATION

CERES is promoted by the Central European Initiative through its Executive Secretariat in cooperation with 5 partner institutions, namely:

- ⇒ International Centre for Theoretical Physics ICTP;
- ⇒ International Centre for Genetic Engineering and Biotechnology ICGEB;
- ⇒ Cluster in Biomedicine CBM;
- ⇒ International School for Advanced Studies SISSA;
- ⇒ Synchrotron ELETTRA.

These institutions cover a large spectrum of highly relevant fields of scientific research such as physics, maths, genetics, biotechnology, neurosciences, nano-sciences, bioinformatics: in line with the bottom-up approach pursued by all Marie Curie Actions, fellows will be given the chance to choose the topic of their research projects, as well as their host institution.

III. ELIGIBILITY CRITERIA

- Nationality: CERES Fellowships are awarded to nationals from CEI Member States; considering
 that the abovementioned host institutions are located in Italy, and taking into account that CERES
 supports incoming mobility, Italian nationals are not eligible.
- **Degree requirements**: CERES Fellowships are awarded to "experienced researchers", i.e. to candidates holding a PhD or having at least four years of full-time equivalent research experience;
- **Language requirements**: fluency in the English language is mandatory.

IV. DURATION OF THE FELLOWSHIP

12 months.

V. CONTRIBUTION FOR THE RESEARCHER (living, mobility and travel allowance)

Indicative average value of 24.500 € / year (including social security and employment costs).
